It is a mark of distinction and recognition reserved for those Arrowmen who, by reason of exceptional service, personal effort and unselfish interest, have made distinguished contributions **above and beyond the immediate responsibilities of their position or office** to one or more of the following: their lodge, the Order of the Arrow, Scouting or their Scout camp. *Under no circumstances should tenure in Scouting or the Order of the Arrow be considered as reason enough for a Vigil Honor recommendation.* Only Arrowmen who have achieved Brotherhood at least 2 years as of August 15th will be considered for this year's Vigil nominations to the National Order of the Arrow.

The Vigil Honor is the highest honor that a lodge may bestow upon one of its members. As such, much thought and consideration should be given to any prospective nominee. By submitting this nomination, you assume significant responsibility for ensuring that our Vigil Honor members represent the highest ideals of Scouting and of the Order of the Arrow. Vigil Honor membership is not a rank or advancement and it cannot be won by conscious endeavor on the part of any individual. Rather, it comes as recognition, by one's fellow Arrowmen, of unselfish leadership in service.

Vigil Honor members should be Scouts of integrity and character and they should be exemplars of our philosophy of servant leadership. The Vigil Honor Committee is looking for Arrowmen who have a proven record of service to others and who exemplify in their daily lives an unmatched devotion to a life of cheerful service to others. But remember, more than any award in the Order of the Arrow, Vigil Honor members are chosen more for what is expected of them in the future than for what they have done thus far.

From among the nominees each year, the Mikanakawa Lodge Vigil Honor Committee must select those who should be recognized by the conferring of the Vigil Honor upon them. We must then submit our petition to the National Order of the Arrow for their approval of our selections. The question we are required to answer is, "Why is this Arrowman worthy of the conferring of the Vigil Honor - now?"
